Utility Negligence - The gas to a family home was cut off in Opelousas for non-payment and a lock installed; the lock was flimsy and the family patriarch broke it and began stealing gas – his jerry-rigged connection was poor and the house exploded in the middle of the night when a cigarette was lit – six plaintiffs in the home (including wife, children and grandchildren) were all injured in the explosion

Father broke the lock with a wrench and fugitive service was restored. However in this jerry-rigged restoration (it was theft of gas too), it was forgotten that there was an open gas line where a gas appliance had formerly been. Natural gas was leaking into the home.

In the middle of the night on 6-15-03, Brenda Jones (Father's wife) lit a cigarette. The house blew up and windows were shattered.
