Lavonne Srock, then age 62, was a front-seat passenger on 12-16-97 with her husband, Dallas Bahr. Bahr was driving a full-size RV. The couple who live in Minnesota were traveling through Memphis on I-40 near the Germantown Parkway. On this date, traffic was slowed for construction work.

Ahead of Bahr RV on I-40 was a tractor-trailer driven by Tomarz Horacy for a Canadian trucking firm, Bison Transports. Horacy recalled that as the traffic in front of him slowed, he too stopped and/or slowed to very nearly a stop. He next remembered being rear-
