On the morning of 10-26-01, Jennifer Whitwell, then age 17, was on the way to Germantown High School. She traveled on Isleworth Drive. At the same time, a fellow student, Laura Bray, was also

heading to the high school after attending an early morning Bible study.

Bray approached Isleworth on Eggleston Road – Bray believed the intersection was a four-way stop. She stopped and then started forward. Bray fully expected Whitwell to stop. As it was not a four-way stop, Whitwell didn't stop and a moderate collision resulted. Fault was no issue.

Whitwell has since treated for low-back pain and a soft-tissue ankle injury. She has also reported psychiatric symptoms – they included sleeplessness, anxiety and depression. In this lawsuit, Whitwell sued Bray and sought money damages. Bray, now a student at BYU, defended the case and minimized the claimed injury.
